

TREATY
OF
ALEXANDREȘTI

BETWEEN
THE CO-DOMNITORI OF THE CARPATHIA

09 JULY 2016



Proclaimed at Alexandrești, 09 July 2016.

THEIR ROYAL HIGHNESSES Oscar and Alexander XII, hereinafter jointly referred to as the contracting parties, desiring to maintain and further develop peace and friendship between the Empire of Karnia-Ruthenia and the Empire of Pavlov, as well as in the Principality of the Carpathia.

CONVINCED that the strengthening of good-neighborly relations and friendly co-operation between the Empires is in accordance with the fundamental interests of the peoples of the two countries to realize changes in the administration of the Principality of the Carpathia,

HAVE decided for this purpose to conclude the present Treaty in accordance with the principles of an increasing co-existence jointly affirmed by the two Empires,

HAVE examined the subject and found an agreement in good and due form,

HAVE agreed upon the following:

Article I

The Contracting Parties saw fit that His Royal Highness, Oscar must abdicate from the Princely Throne of the Carpathia and keep the Principality of the Carpathia only under the auspices of His Royal Highness, Alexander XII.

Article II

The remaining Domnitor of Carpathia agrees to maintain the Principality as state member of the Karno-Ruthenian Empire, and will, from the signature of the present document and for all official and administrative matters, be a state of this Empire and will be, from this moment on, submitted to her laws, Constitution and Emperor.

Article III

The Contracting Parties agree to keep the terms of the treaty indefinitely, preserving the conditions that provide the signing of the present document.

Article IV

Any difference or dispute arising out of the interpretation or application of the present Treaty shall be settled by negotiation through normal non-public diplomatic channel.

Article V

Would the implementation of this Treaty becomes infeasible to both parties, the signatories agree to restore the *status quo ante*.

THE present Treaty will come into force immediately on the exchange of the instruments of ratification and will remain in force for an indeterminate period.

UNLESS either of the Contracting Parties gives to the other notice in writing to terminate the Treaty at least one month before the intended date to do so, it will remain in force without any specified time limit, subject to the right of either of the Contracting Parties to terminate it by giving to the other in writing a month's notice of its intention to do so.
